#### **Course Overview**

This introductory 5-day (40-hour) course is designed to provide the new fire investigator with the prerequisite knowledge necessary to properly determine the origin and cause of a fire and to refresh the experienced fire investigator with his/her current knowledge base as it relates to the scientific investigation of a fire scene. This course is instructed through both a <u>classroom</u> and a <u>hands-on</u> component (an actual fire scene investigation) and meets the requirements of NFPA 1033: Standard for Professional Qualification for Fire Investigator as well as NFPA 921: Guide for Fire and Explosion Investigations. NFPA 1033 lays out the minimum qualifications for a fire investigator, while NFPA 921 contains the basic knowledge base and methodologies required to comply with the NFPA 1033 requirements.

### **Topics Addressed**

Students will be oriented to effectively work using a "Team Concept" built around a specific investigative protocol tailored to fire and explosion investigations. Students will examine the most up-to-date theories of fire investigation and the role of the fire investigator. The main topics include: the methodology of fire investigation; motives of arsonists; incendiary fires; explosions; and the formulation and testing of a hypothesis regarding the origin and cause of a fire. Additionally, Students will learn about fire behavior, basic cause & origin, investigative techniques, scene preservation, documentation, evidence collection and legal aspects for fire investigators.
